GLOBAL TRENDS IN CHANGING INDIA:

World is distributing its work - India is becoming IT Hub, China is becoming world's factory, Gulf is already world's oil reserves, France is hub for fashion, America is world's war and weapon industry and of course Afghanistan and Pakistan are world's terror factory. Open Market, Free trade practices are resulting in boundary less economics.

Anti-Globalist claim that this thinking is not just Indian but international movement worldwide which believes that companies are acting only for market access and have nothing to do with human rights or social culture or public welfare.

IT'S A GLOBAL VILLAGE AND ENTIRE WORLD IS MY PLAYING FIELD!!!

Many great things today can only be done at international level with countries coming together for a common purpose and not just at national level. At the end of the day it doesn't matter which company you are working for, what matters is that your country, your society and you have a job and are together progressing towards peace and progress. Some say philosophy of "a global village" is not new; Indians were the first who called Vasudev Kutumbhukam.

IS GLOBALISATION IS JUST ANOTHER NAME OF PROFIT MAKING?

People expect global companies to have global responsibilities. They hope globalization will give answers to world's problems of poverty, food and shelter. BUT Multinationals are not coming for social welfare, they are coming for money. Someone has said, "The business of business is business"; which is to make money and not social welfare. WHY SHOULD WE SEE AS GLOBALISATION AS REMEDY TO PROBLEMS OF THE WORLD?
